Antarctic adventure welcomes White Oak alum

Robert Early was out of the country for Turkey Day, but he spent a 'Friendsgiving' closer to the South Pole with a parcel of new pals as a penguin posse welcomed the White Oak alum to Antarctica this month.

The 19-year-old Aggie and 35 other Texas A&M students are currently on 'The Ice' and out of contact to avoid the world's worst roaming charges while visiting the base of the globe. With her son exploring the seventh continent, Danielle Early provided a quick update Monday.

"The attire we had to buy for him, from the base layers to the outer layers to the special pants and stuff was just amazing to me," she said. "I've been snow skiing, so I know about some cold weather equipment, but I didn't know about any of this at all."

Par for the course when headed for the windiest, coldest continent on Earth, and good thing, too - the group has already weathered a "substantial snowstorm" according to reports from the expedition lead, who has some online access to send out updates, including photos.

Departing Nov. 16, "They flew out of Houston, and they went to Buenos Aires first," Danielle Early said, before another trip further south: "They landed the second time in Ushuaia, Argentina. They spent a few days there, taking in some sights and experiencing the culture."

"They got on a ship specially designed to go through the ice and other things down there and made their voyage to Antarctica."

That leg of the adventure got mom's blood pressure up.

"They had to go through the Drake Passage where seas converge," she noted. "It's the roughest waters, the most dangerous in the world. There's about 800 ships at the bottom of it. I didn't know that until right before he was leaving."

"I was delighted when I knew they were on the other side of it in Antarctica, because my momma heart was worried."

First responders get ready for water rescues

Frankly, none of the firefighters really took the time to check how cold the water was, they just got to work.

"We didn't put a thermometer in," Gladewater Fire Chief Mike Simmons said. "No one really wanted to know."

Needless to say, Lake Gladewater's pretty cold right now.

Simmons put on a dry suit as well as first responders from Gladewater, Longview and Sabine got special water rescue training this week at the city's primary water source. Almost a score of the various departments' personnel attended one of the three days of exercises, including water rescue drills and skills as well as ropes rescue skills.

With the suit keeping moisture off the body, Simmons said Monday, "The reality is it was warmer in the water than it was standing on the shore with the wind blowing over you."

Key tasks for the trainees ranged from the best ways to enter the water in the midst of an emergency to refining their defensive swim position, proper boat paddling and boat flipping, rope-bag throwing and how to properly drag victims in and out of the boat during a water rescue.

The trainees' water rescue equipment was covered by a granted

Gladewater continues positive run on sales tax revenue

Texas Comptroller Glenn Hegar announced last week he will send cities, counties, transit systems and special purpose districts \$1.2 billion in local sales tax allocations for November, 1.9 percent more than in November 2022.

These allocations are based on sales made in September by businesses that report tax monthly and on sales made in July, August and September by quarterly filers.

Gladewater remained on the positive side of the tally sheet - 23 months in a row - while many other Gregg County cities listed negative numbers. Gladewater posted a 1.60-percent increase over the same period in 2022, while White Oak posted a -4.35-percent in sales tax revenue.

Abbott: Battle continues over vouchers

As time runs out next week on the fourth special session, Gov. Greg Abbott said he will continue to fight for school choice, despite the Texas House once again decisively rejecting it when 21 Republicans largely from rural districts joined Democrats in stripping it from a \$7.6 billion education bill. The Austin American-Statesman reported it is unclear what Abbott's next move will be.

"I will continue advancing school choice in the Texas Legislature and at the ballot box and will maintain the fight for parent empowerment until all parents can choose the best education path for their child," Abbott said. "I am in it to win it."

However, Abbott has not said whether he will call a fifth special session. He has previously said that he would back primary opponents to those who rejected the voucher plan.

"I don't know whether the Governor will call us back for a 5th special session or not," state Rep. Cody Harris, R-Palestine, said in a Facebook post Sunday. "Either way, I look forward to the next time I have the opportunity to provide much needed teacher pay raises, increased funding for our local schools, and parents with the opportunity to choose the system of education they believe is best for their child."

The filing period for the March primary is underway and ends Dec. 11.

Widespread power outages possible

The agency in charge of the state's power grid is warning that Texas could face widespread power outages this winter if temperatures plunge below freezing for several days in a row, as occurred last year. The Electric Reliability Council of Texas raised the alarm after canceling a plan to ask power plant operators to reactivate some closed natural gas and coal plants. It received few offers to do so, The Dallas Morning News reported.

ERCOT is predicting a 14.4% chance of rolling blackouts if the state experiences a severe cold snap such as occurred just before last Christmas. Those chances grow to 16.8% in January, according to the report.

Population and business growth are the main drivers of energy shortages on the ERCOT grid, The News reported.

Texas State to host first presidential debate

The first presidential debate for the 2024 general election will be held at Texas State University in San Marcos, the Statesman reported. The Sept. 16 debate will be the first of four to take place next year.

Kelly Damphousse, president of Texas State since July 2022, said he believes the university, with nearly 39,000 students,

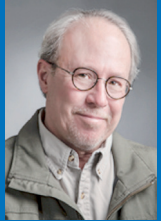
is a great gift. My friend reminds me to laugh and for that I am very, very grateful.

was chosen because of its legacy with former President Lyndon Johnson, who graduated from there, and its facilities.

"Texas State looks a lot like the state of Texas demographically. We are almost all Texas students here, more than 95%," he told the Statesman. "And so I think in many ways we look like a great opportunity for them. Not just our facilities, not just our campus, but just the entire story must have looked attractive to them."

800,000+ Texas children lose health care

Of the 1.4 million Texans who have lost health coverage through either Medicaid of the Children's Health Insurance Program, 58% — or 812,000 — are children, The News reported. This follows the end of pandemic-era continuous Medicaid renewals.

"We knew we were going to have problems, to be candid. I'm sorry we're seeing the kind of numbers that we're seeing," said Steve Love, president and CEO of the Dallas-Fort Worth Hospital Council. "This is going to really exacerbate the problems we already have with the uninsured in Texas."

Nearly 70% of people who lost Medicaid coverage in Texas were booted off for procedural reasons, such as failing to return renewal packet requests. The state has the highest rate of uninsured people in the country.

Texas leads nation in annual job growth again

The state again reached a record high nationally with 14.536 million Texans at work, according to the Texas Workforce Commission. The state's seasonally adjusted jobless rate held steady at 4.1%.

"The Texas economy continues to grow, and there are nearly 480,000 job listings for individuals with the right skills, which TWC can help provide," TWC chairman Bryan Daniel said.

The latest report marks the 10th consecutive monthly increase in jobs, with the addition of 21,000 more Texans on payroll, TWC reported.

We're number one! In feral hogs.

It likely comes as no surprise to rural residents, but even city dwellers are having their yards and gardens ravaged by feral hogs, which have been reported in 99.6% of Texas counties. The only exception thus far is El Paso County, according to new data from the University of Georgia.

Family Fortunes ...

Every three years, the Board of Governors of the Federal Reserve System releases results of the Survey of Consumer Finances. The Survey looks at family income, net worth, debt, and other indicators of the financial health of US families. The most recent report covers the interesting time period from 2019 (just before the COVID-19 pandemic) to 2022.

Let's explore a few interesting findings.

Although the pandemic has been devastating in many ways and the shutdowns and other disruptions to business activity caused massive dislocations, the Survey indicates that US families were actually better off financially due to the historic infusion of funds.

Income was up whether measured by the mean (average) or median (where half are above and half are below). The

2022 household income number reflects earnings in 2021, and many families were benefitting from pandemic-related federal relief packages. While the resulting enhanced unemployment and other benefits would be reflected, information on many stimulus payments was not included. Income increases were measured for most age groups and races/ethnicities. The highest median income group was Asian, with a median income of \$122,600, followed by White non-Hispanic (\$81,100), Hispanic/Latino (\$46,700), and Black (\$46,000) families. Not surprisingly, income remained highly correlated with education.

Looking at net worth (the difference between assets and liabilities), housing and equities both rose at rates outpacing general prices, leading to significant gains. Real median net worth was up 37% to \$192,900, and real mean net worth increased by 23% to reach almost \$1.1 million (obviously, wealthy households bring up the average). Net worth rose for all age ranges and education levels. Particularly notable percentage gains occurred in younger and less educated families.

The reasons for the improvement in financial wellbeing are varied. For many families, massive stimulus payments were used to pay down debt and increase wealth. Housing-related debt was fairly stable, but credit card balances dropped noticeably.

Homeowners' net worth was positively affected by soaring home prices. In fact, the Survey found that, for families that owned their home, the median net housing value (the value of a home minus the mortgage) rose from \$139,100 in 2019 to \$201,000 in 2022. The flip side of the surging housing market is that affordability fell to historic lows, with the median home value more than 4.6 times the median family income.

Despite the immeasurable human cost and dislocations accompanying the pandemic, it is interesting that from a purely financial perspective, most families were better situated in 2021 than they were in 2019. Nonetheless, it remains to be seen how future surveys will look given high inflation, a lagging housing market, the expiration of various stimulus initiatives, increasing consumer debt, and other issues surfacing since that time. Stay safe!

SALVATION BY GRACE THROUGH FAITH

"For by grace are you saved through faith; and that not of yourselves; it is the gift of God" (Eph. 2: 8). Grace is the summation of all that God has done to bring salvation to humanity. Grace summarizes God's part in man's salvation, faith summarizes man's response to God. You will notice that "grace alone" or "faith alone" is not found in the text.

In the New Testament the idea of having "faith," or "believing" is often used in a general or comprehensive way to include one's entire response to God. For example, in Acts 16: 24-34 is recorded the conversion of the jailor at Philippi. When the jailor asked Paul, "What must I do to be saved?" he was told, "Believe in the Lord Jesus" (vs 30-31). Paul then spoke unto him "the word of the Lord," and he and his household were baptized (vs. 32-33). After the jailor was baptized he rejoiced, "having believed in God" (v. 34). This illustrates clearly that belief included obedience in baptism.

Why then, do people insist, that the proper response of faith, is "faith ONLY" or "faith ALONE?" The only time "faith alone" or "faith only" appears in the New Testament in connection with salvation or justification is Jas. 2: 24, which says, "You see then how that by works a man is justified, and NOT by faith ONLY."

The concept of belief includes "conviction, trust, and obedience." In the Bible, faith approved by God is always characterized by these comprehensive elements i.e., "conviction, trust, and obedience." Faith is always demonstrated in obedience i.e., the faith that saves is always the faith that obeys! Since the Ephesians were saved by grace through faith, what did that involve? Acts 19: 5 says that when they were told that they should believe on Jesus Christ (v. 4), "When they heard this, they were baptized in the name of the Lord Jesus." Thus, salvation by grace through faith, includes baptism rather than excluding it, as many teach. Think on these things.

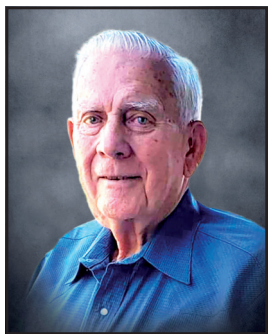

Upshur commissioners to meet Thursday

Upshur County Commissioners Court will consider discussing, and acting on, the upcoming major renovation of the county courthouse Thursday (Nov. 30). Part of the potential discussion, and all votes, if any, are to take place in open session at the 10 a.m. meeting at the temporary courthouse, 150 E. Jefferson on the downtown Gilmer square.

Among other items on the agenda is discussing nominees for boards of the county's two emergency services districts. Some members' terms expire Dec. 31. The court will also consider the \$124,900, 5-year lease/purchase of a backhoe with annual base payments of about \$15,000. The agenda doesn't list the seller. In other business, the court will consider casting votes for the Upshur County Appraisal District's Board of Directors.

The court will also consider contracting with the Kilgore-based East Texas Council of Governments to provide the county with certain services. In addition, commissioners will consider approving auctioning off some Road and Bridge Department equipment, and accepting a bid on scrap metal disposal for that department.

General Permit Authorization No. TXR040680



PRELIMINARY SEWER SYSTEM (MS4)

APPLICATION AND PRELIMINARY DECISION. City of White Oak, 906 South White Oak Road, White Oak, Texas 75693, has applied to the Texas Commission on Environmental Quality (TCEQ) under Texas Pollutant Discharge Elimination System (TPDES) Small MS4 General Permit No. TXR040000 for a new authorization number TXR040680 to discharge stormwater to surface water in the state from the City of White Oak MS4. The new authorization would replace expired authorization number TXR040629. The notice of intent (NOI) and stormwater management program (SWMP) were received by the TCEQ on January 22, 2020.

The MS4 is located within the City of White Oak city limits located within the Longview Urbanized Area in Gregg County, Texas. The discharge from the MS4 will eventually reach Sabine River Above Toledo Bend Reservoir in Segment No. 0505 of the Sabine River Basin.

A copy of the NOI, SWMP, general permit, and general permit fact sheet are available for viewing and copying at City of White Oak City Hall located at 906 South White Oak Road, White Oak, Texas 75693. The SWMP can also be viewed online at the City of White Oaks's website at <https://www.cityofwhiteoak.com/>. Substantial changes to the MS4's SWMP during the permit term will be posted on the same website.

The TCEQ Executive Director has completed the technical review of the application and SWMP. The SWMP, if approved, would establish additional terms and conditions, not included in the general permit, under which the MS4 must operate. The Executive Director has made the preliminary decision that the SWMP meets all statutory and regulatory requirements and made a preliminary decision to approve the small MS4's authorization under the TPDES Small (Phase II) MS4 General Permit No. TXR040000.

PUBLIC COMMENT / PUBLIC MEETING. You may submit public comments or request a public meeting about this application. The purpose of a public meeting is to provide the opportunity to submit written or oral comments or to ask questions about the application. The TCEQ will hold a public meeting if the Executive Director determines that there is a significant degree of public interest in the application or if requested by a local legislator. A public meeting is not a contested case hearing. If significant interest exists, the Executive Director will direct the applicant to publish a notice of the public meeting and hold the public meeting. The applicant must publish notice of a public meeting at least 30 days prior to the meeting in a newspaper of general circulation in the county where the MS4 is located. If the MS4 is located in more than one county, the applicant must publish notice in a newspaper of general circulation in the county containing the largest residential population.

All written public comments and public meeting requests must be submitted to the Office of the Chief Clerk, MC 105, TCEQ, P.O. Box 13087, Austin, Texas 78711-3087 or electronically at <https://www.tceq.texas.gov/goto/comment> within 30 days of the date of newspaper publication of this notice.

After the deadline for submitting public comments, the Executive Director will consider all timely comments and prepare a response to all relevant material, or significant public comments. The response to comments will be mailed to everyone who submitted public comments and to those persons who are on the mailing list for this application.

MAILING LIST. Upshur Special Investigations Unit makes arrests

The Special Investigations Unit of the Upshur County Sheriff's Office arrested five suspects on felony drug charges in October, including four at one time, Sheriff Larry Webb said.

Details, based on a report from sheriff's Lt. Gary Shirley, were as follows, and all those arrested were taken to the county jail in Gilmer, Webb announced on Wednesday of last week:

Four persons were apprehended in a Oct. 10 traffic stop

which resulted in seizing two suspected drugs in the Pritchett community.

Arrested were Meonca E. Jones, 26, of Ore City, and three from Gilmer - Kaylie B. Jackson, 23, Autumn S. Livas, 21, and Brandon C. Barnes, 28.

All were charged with two counts each of manufacture/delivery of a controlled substance--between four and 200 grams of cocaine, and the same amount of Adderall, a prescription drug.

The unit was working drug interdiction in the Pritchett

area when it confiscated eight grams of suspected cocaine, and 37.6 of suspected Adderall. The suspects were stopped at the intersection of FM 1404 and Texas 155.

Joshua Allen Lewis, 32, of Ore City, was arrested Oct. 2 on a charge of manufacture/delivery of controlled substance--between one and four grams of methamphetamine.

The unit was performing drug interdiction in the Ore City area when it stopped his vehicle at the intersection of U.S. 259 and FM 557, resulting in seizing 3.29 grams of the drug and a "large amount of cash."

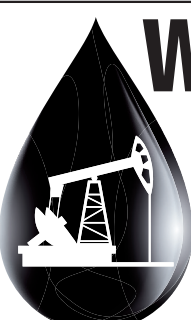

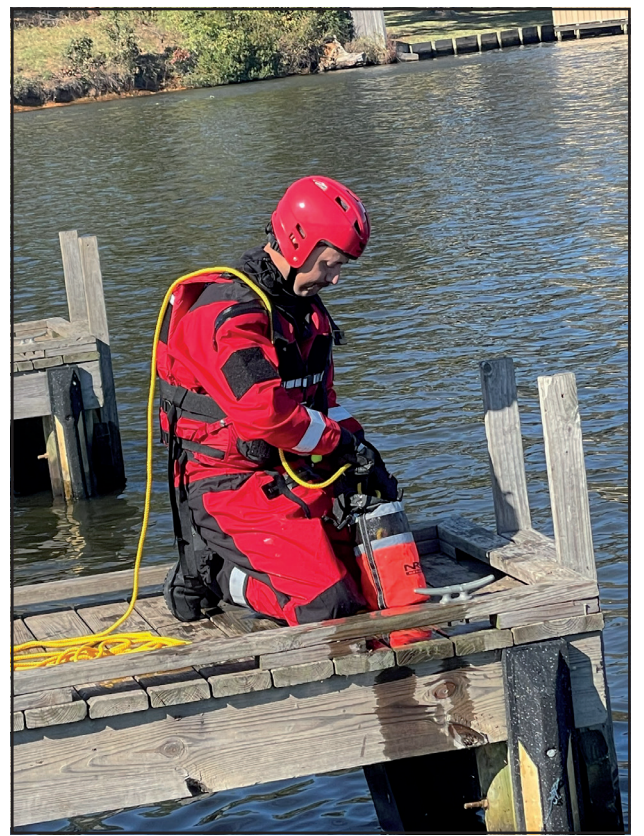

At this point in the adventure, though, Danielle's reveling in the snapshots she's collected: Robert unfurling an Texas A&M Corps of Cadets Company A2 flag, dipping a hand in the frigid waters or posing with a 'White Oak FFA' sign and a cool smile amid the barren landscape while penguins photo-bomb the shot.

Double majoring in Psychology and Anthropology, Robert recently described tentative research plans for the trip, such as studying the growing effect human observation has on the species of Antarctica that were previously isolated from the Anthropocene or analyzing social behavior of penguins exposed to Avian influenza."

He's attempted to explain it all before, Danielle said, but "I can't really explain it to you," she adds with a laugh.

She's hungry for more details but being patient. For now, Danielle understands the team is visiting different spots on their itinerary and spending their nights on the ship, water and weather permitting.

Important for mom, "He will be back in time for Christmas, about the middle of December."
